The Nova Scotia College of Dietitians and Nutritionists (NSCDN) is seeking a dietitian with an active-practice license to join the Board of Directors. The College is governed by its Board of Directors, which is composed of dietitians and members of the public appointed by the Governor in Council.

Board of Directors Information

In addition to meeting the requirements established by law and bylaws, NSCDN's board of directors will be accountable to provide effective oversight, stewardship and strategic leadership. The Board will ensure that NSCDN affairs are conducted in a way that achieves the College's mission and vision and reflects values.

The activities of the Board are conducted in accordance with the Act, Regulations, Bylaws and relevant NSCDN policies.

The Board is composed of the chair, the chair-elect, the past chair and the treasurer; two members at large; and two to three public members. It normally meets four times per year. Meetings may be held in person or virtually. Travel costs are covered by the NSCDN for those who reside outside of the geographical location of where an in-person meeting is held. An honorarium is provided to NSCDN Board members to help offset the personal financial cost of their volunteer hours.
