BECOMING QUALIFIED IN YOUR PROFESSION

Dietetics is a regulated occupation in Canada which means you must be registered to work as a Dietitian.

To apply to be a Registered Dietitian you must apply to the Dietetics Association of Nova Scotia. **You can apply before you are approved to immigrate.**

LANGUAGE

To work as a dietitian in Canada, you need a high level of English language. You will need to take a language assessment. Consult <https://www.nsdassoc.ca/applicants/international-applications> for information on language proficiency. You may want to take an assessment and take steps to improve your English before coming to Canada.

To apply for immigration to Canada, you will also need to demonstrate language proficiency.

Start as soon as possible! Participate in English language classes in your home country. Try the “self-directed study online” language courses offered by ISANS. These are open to you even if you do not have immigration status.
